TERMS AND CONDITIONS

- Each bidder shall have to deposit an earnest money for the lump sum amount of Nu. 5,000.00 (Ngultrum five thousand) only in cash with Samdrup Jongkhar Thromde latest by 10:00 AM BST on the day of the auction to qualify him/her to the auction bid. Upon the receipt of the earnest money, token card will be issued to identify the qualified bidder. No person shall be allowed to bid in the auction without holding token card.
- The highest bidder, whose bids are accepted shall have to deposit a spot payment of 50% of the auction value (non-refundable) at the fall of the hammer and balance within 10 (ten) days from the day of auction failing which accepted bid shall be canceled and the earlier deposits forfeited.
- The highest bidder whose bid will be accepted by the auction committee will have to complete the dismantling works and dispose-off the items from the site at their own cost against full payment of the auction value (cash or demand draft from any of the financial institution of Bhutan drawn in favor of Executive Secretary, Thromde Administration.
- The auction committee reserves the right to accept the bid on the spot or any subsequent date. In case of any dispute or problem with regard to the auction, the decision of the committee shall be final and binding.
